VOLUNTEERING WITH HVNA

I. Volunteer Engagement Philosophy

Volunteers are one of the greatest resources that we have at Hespeler Village Neighbourhood Association. People like you, who give their time, energy, and talents to our organization are essential to our ability to deliver quality programs and services to our community. We are committed to creating opportunities for the community to be involved in our work, and many of our programs would not be possible if not for volunteers. Our program volunteers and volunteer Board and Advisory Committee members are extremely valuable.

II. Volunteer Engagement and HVNA's Strategic Plan

Volunteer engagement is an essential part of the association's strategic plan. Our goal is to grow the image of Hespeler Village Neighbourhood Association, and it is through the work of volunteers that we can do that. Having more volunteers means that we can take more participants into programming and have bigger community events. Volunteers will help us create a community image that we are a space for ideas to be created and for the community to grow, not just a community centre. To us, it is key that we build a family-like atmosphere where both volunteers and staff feel as though they are part of something bigger.

III. Benefits to Volunteering with the HVNA Community

As a volunteer with Hespeler Village Neighbourhood Association, you will have the opportunity to provide services to:

- Children and youth in our community
- Special events that enhance our community

You will have the opportunity to use and enhance your personal skills and gain valuable experience that will help you in the future. At HVNA, we strive to give our volunteers a positive working environment, necessary training, supervision, evaluation, and recognition to ensure they enjoy their time as a volunteer.

IV. Volunteer Rights and Responsibilities

We hope that our volunteers will honour their commitment to HVNA, respect other staff and volunteers, and perform their assigned duties to the best of their abilities.

Volunteers have the right to:

- Work that is meaningful and satisfying to them
- A proper orientation and training to enable them to complete their tasks
- The opportunity to be heard, to make suggestions and to be respected
- The opportunity to decline a suggested placement
- Recognition for tasks completed
- Refuse unsafe work

Volunteers are responsible for:

- Getting to and from the location in which they are volunteering
- Being punctual
- Tracking their volunteer hours
- Having fun!

V. Code of Conduct

Appropriate conduct and behaviour include, but is not limited to:

- Adherence to published policies, practices, and procedures
- Representing HVNA in the most positive manner in every setting
- Competent performance of all assigned duties
- Prompt and regular attendance
- No cell phone use during working hours
- Proper and appropriate attire - HVNA provided shirt, pants or long shorts in summer, and lace-up shoes. Footwear such as Crocs and sandals/slides are not appropriate.

VI. Misconduct

HVNA expects volunteers to reflect our mission, vision, and values. We expect volunteers to treat everyone they encounter with respect and kindness. Any gross misconduct as listed below or as determined by a supervisor is grounds for HVNA asking said volunteer to leave the program immediately. Gross misconduct that will lead to a volunteer's immediate termination are as follows:

- Theft
- Harassment of any nature
- Physical violence
- Possession or use of a firearm or other weapon on HVNA property
- Possession or use of illegal drugs on HVNA property
- Deliberate disclosure of HVNA confidential information
- Other (as determined by HVNA management)

VII. COVID-19, Health and Safety

The health and safety of our volunteers in HVNA programs are of crucial concern to HVNA. We strive to attain the highest possible level of safety in all activities and operations. HVNA intends to comply with all health and safety laws applicable to our organization, as well as adhering to the guidelines given by Public Health for pre-screening, cleaning, and sanitization protocols. As part of your orientation, you will receive applicable health and safety training required for your position. Our health and safety manual is updated regularly. An updated version of our health and safety policy is posted in the HVNA office. Unsafe conditions, acts or potential hazards must be reported to your supervisor immediately, even if you believe you have corrected the problem.

VIII. Attendance and Punctuality

Attendance and punctuality are very important for a program to operate smoothly and effectively. Volunteers need to be on time and ready for their position. HVNA recognizes that there may be times when volunteers will not be able to come in. If you are sick, have a family emergency etc. we ask that you give as much notice as you can to the Community Engagement Coordinator, so that we can plan accordingly. If you are running late due to traffic or other circumstances, we ask that you call the HVNA office so that we know to expect you later.
